#### Food Vendor Suggestions

In the spirit of Blacksburg Fork & Cork, a food, wine and art festival, it is our goal to encourage attendees to try a variety of food options throughout the day just as they are sampling a variety of wines. Each restaurant is encouraged to try and include the following elements when planning their menus:

- 1. Appetizer Portions: A minimum of 2 appetizers to be offered, or you may serve only appetizers if you prefer. All appetizers must be priced between \$1 and \$5 each.
- 2. Samples: Vendors are strongly encouraged to offer samples to festival attendees. Samples should be bite-size and not full meals.
- 3. Food Offered for Sale: All menu items (including appetizers) must be on your regular menu or specials that highlight your restaurant's overall style. Adjustments may be made to accommodate equipment differences, portion sizing, pricing restraints, and ease of service, but should be consistent with the overall style of your restaurant. If you wouldn't serve it in your restaurant, don't serve it at Fork & Cork! Only non-alcoholic beverages are allowed for sale at restaurant booth spaces.

#### **Terms and Conditions**

- 1. Event coordinators reserve the right to accept or decline any application. Applicants are accepted on a first-come, first-served basis with a limited numbers of available spaces.
- 2. Set-up will begin at 8:00 a.m. on Saturday, April 21, 2018. All vendors must be in place and vehicles removed by 11:00 a.m.
- 3. All participants must operate on Saturday, April 21st from 12:00 pm to 6:00 pm. For the safety of our attendees, no wineries or other vendors will be allowed to bring vehicles into the festival area before 6:20 p.m. to pack up their booths.
- 4. Booth equipment such as cooking and serving equipment, tents, tables and chairs must fit within the 10' x 20' space provided. **TENTS MUST BE WEIGHTED AND SECURED.** Each restaurant is responsible for providing their own tables, equipment, linen, signage, etc.
- 5. Food vendors must obtain a health permit. The Blacksburg Partnership will facilitate the permit process and must receive payments and applications directly. Payments and applications from all food vendors will be submitted at once by The Blacksburg Partnership. Make \$40 checks for temporary health permit out to "MCHD" (Montgomery County Health Department).
- 6. Every food vendor must have a currently inspected 5lb or larger ABC fire extinguisher on site. If a fryer will be in use, a K-style fire extinguisher is required. Food vendors must abide by all requirements on the Temporary Restaurant Checklist.
- 7. All vendors must state the items they will be offering in advance to avoid duplications and provide an interesting variety to the attendees.
- 8. Four full-festival (wine tasting) wristbands will be provided for restaurant staff working the festival (must be 21 or over). Additional restaurant staff will be provided general admission (non-tasting) wristbands. All restaurant staff must check in at Vendor Check-in prior to their shift to obtain wristbands.
- 9. Each vendor will be responsible for his/her property. The Blacksburg Partnership and Virginia Tech Corporate Research Center and their officers, agents, employees and volunteers are not responsible for any damage, theft, or loss for any reason.
- 10. Electricity will not be provided to vendors or wineries. If accepting credit card payments for food purchases, please bring manual or wireless credit card machines.
- 11. REGISTRATION FEES ARE NOT REFUNDABLE UNDER ANY CIRCUMSTANCE.
- 12. The festival will go on **RAIN OR SHINE**.
